### Regulatory Acknowledgment

I acknowledge and understand that I am bound by **OHF Regulations F5 – Restriction on Team Officials Changing Associations:**

- A person registered as a Team Official with one Minor Hockey Association may not, without the consent of that Association, be registered or appear on the bench in the following season for a team with the same birth year.
- This restriction also applies to U18 AAA or mixed-age teams in the same division.
- Consent must be provided in writing before the new Association can announce or appoint the individual.
- The former Minor Hockey Association may withhold consent at its sole discretion.
- Violation of this regulation may result in a \$1,000 fine and the individual's ineligibility to register with the new Minor Hockey Association for that season.



**APPENDIX 3.06C - SHA Team Official Release Form**



I acknowledge and understand that I am bound by **OHF Regulations F6 – Team Official’s Commitment Form:**

- Any individual accepting a Team Official position with a Minor Hockey Association for the following season should sign a commitment form.
- Any action negating such commitment without mutual consent may result in ineligibility to register with another Association for the committed season.
- Consent from the former Minor Hockey Association must be granted in writing before signing the Team Official Commitment Form.
- If multiple commitment forms are signed, the first one filed with the Member Office prevails.

I acknowledge and understand that I am bound by **SHA Policy 3.06.04(a) – Expectations and Responsibilities:**

- All SHA registered team officials must obtain written permission from SHA to seek a position outside of SHA for the following season within the same birth year age group.
- Failure to obtain SHA approval will result in removal from SHA team official eligibility.
- Team officials from all levels ("A," "AA," "B," "BB," "MD," "SL," "HL") may be required to sign the Team Officials Commitment Form (Appendix 3.06B).
